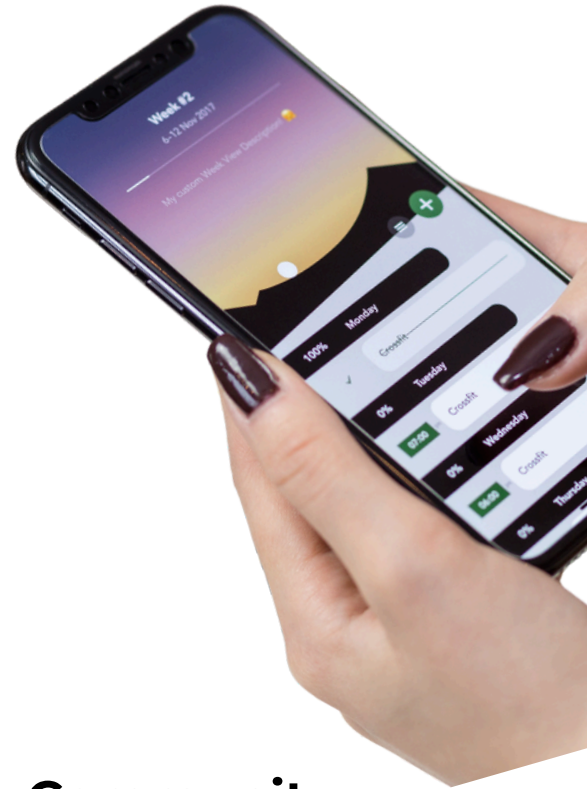

# CALIFORNIA SB1219 2023-2024

**SB1219 WOULD MAKE IT A MISDEMEANOR TO LOITER IN A PUBLIC PLACE WITH THE INTENT TO COMMIT PROSTITUTION, AS DEFINED, AND WOULD MAKE OTHER CONFORMING CHANGES. THE BILL WOULD MAKE A PERSON GUILTY OF DISORDERLY CONDUCT IF THEY OPERATE A MOTOR VEHICLE IN ANY PUBLIC PLACE AND REPEATEDLY BECKON TO, CONTACT, OR ATTEMPT TO CONTACT OR STOP PEDESTRIANS OR OTHER MOTORISTS, OR IMPEDE TRAFFIC, WITH THE INTENT TO SOLICIT PROSTITUTION. THE BILL WOULD AUTHORIZE A COURT TO SUSPEND, FOR NOT MORE THAN 30 DAYS, THE PRIVILEGE OF A PERSON TO OPERATE A MOTOR VEHICLE FOR A FIRST CONVICTION OF THESE OFFENSES. THE BILL WOULD, FOR A 2ND OR SUBSEQUENT CONVICTION, REQUIRE THE VEHICLE USED IN THE COMMISSION OF THE CRIME TO BE IMPOUNDED FOR 30 DAYS, AS SPECIFIED.**

## **PANEL RESULTS 1/25/24**

**ON JANUARY 25, 2024, A PANEL OF NINE SURVIVORS OF HUMAN TRAFFICKING AND INTERPERSONAL VIOLENCE EVALUATED SB1219.**

The group used Love Never Fail's AI Advocate to evaluate SB1219.

Our evaluation process started with the bill's Legislative Counsel's Digest and amendments to Section 782.1 of the Evidence Code, to amend Sections 647, 647.3, 653.23, and 1203.47 of, to add Sections 653.20 and 653.22 to, and to repeal Section 653.29 of, the Penal Code, to amend Section 99171 of the Public Utilities Code, to add Section 13201.5 to the Vehicle Code, and to amend Sections 18259 and 18259.3 of the Welfare and Institutions Code.

We evaluated the content using the following methodology:

1. Review SB1219's Legislative Counsel's Digest  
[www.leginfo.legislature.ca.gov](http://www.leginfo.legislature.ca.gov)
2. Reviewed SB1219's Legislative Counsel Digest using various AI versions.
3. Documented AI Advocate panel interpretation, evaluation, analysis, questions, and discussion of SB1219.

The AI Advocate Committee consisted of nine human trafficking survivors and interpersonal violence; the demographics of committee members can be found at the bottom of this brief.

# **CALIFORNIA SB1219 2023-2024**

## **PANEL INTERPRETATION, EVALUATION, ANALYSIS, QUESTIONS AND DISCUSSION POINTS**

- Question from the group on what lewd means - California Penal Code 647(a) PC defines the crime of lewd conduct in public as the touching of your genitals, buttocks, female breast, or another person's to gratify sexual desires when you know, or should have known, other people were present and might be offended by your behavior.
- Is this only for street exploitation? What about residential and online trafficking?
- What protections are being made to LGBTQ+ community members who reported police harassment?
- Will exit services for survivors be increased?

# CALIFORNIA SB1219 2023-2024

## PROS

- Reverses the impact of SB357 - legalization of loitering for prostitution
- Addresses traffic issues that have resulted from increased loitering

## CONS

- Punishment isn't severe enough: 30-day suspended license and 30 days impounded vehicle? Many folks in impoverished areas have not had access to obtaining a driver's license, so they would not be impacted.
- There should not be any "punishment" for the victims, only DIVERSION requirements (classes, groups, services, etc.)
- Bill does not allocate more funding to exit services for survivors of human trafficking

# CALIFORNIA SB1219 2023-2024

## ORIGINAL LEGISLATIVE COUNSEL'S DIGEST

SB 1219, as introduced, Seyarto. Crimes: prostitution.

Existing law, until January 1, 2023, prohibited loitering in a public place with the intent to commit prostitution, as defined, and made that crime a misdemeanor. Existing law defines specified behavior as disorderly conduct and prohibits that behavior. Under existing law, disorderly conduct includes, among other things, soliciting prostitution, prowling, peeping, surreptitious photographing or filming of an identifiable person, and the distribution of certain images of another person taken under circumstances in which the person understands that the image shall remain private, the distribution of which causes serious emotional distress.

This bill would make it a misdemeanor to loiter in a public place with the intent to commit prostitution, as defined, and would make other conforming changes. The bill would make a person guilty of disorderly conduct if they operate a motor vehicle in any public place and repeatedly beckon to, contact, or attempt to contact or stop pedestrians or other motorists, or impede traffic, with the intent to solicit prostitution. The bill would authorize a court to suspend, for not more than 30 days, the privilege of a person to operate a motor vehicle for a first conviction of these offenses. The bill would, for a 2nd or subsequent conviction, require the vehicle used in the commission of the crime to be impounded for 30 days, as specified.

By creating a new crime and expanding the scope of an existing crime, this bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

- It also expands the definition of disorderly conduct to include specific ways of soliciting prostitution from a vehicle.
- The bill acknowledges it creates new burdens for local law enforcement but avoids any state financial responsibility for those burdens.

## SIMPLER AI

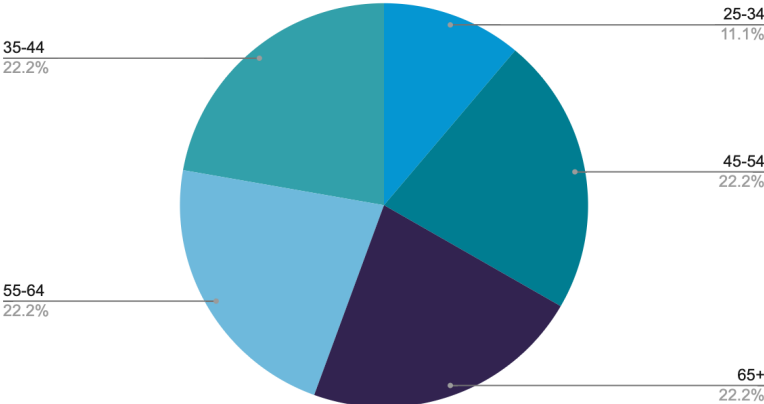

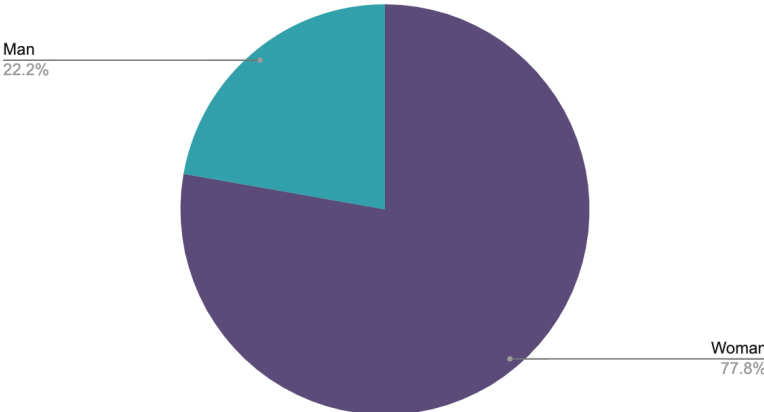

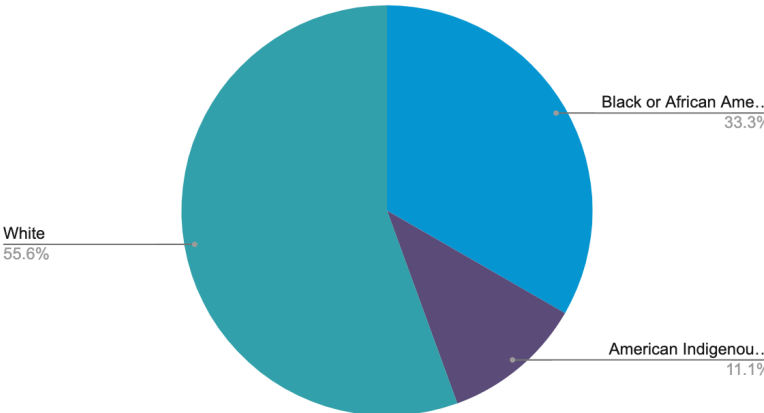
Count of Age



Count of Gender

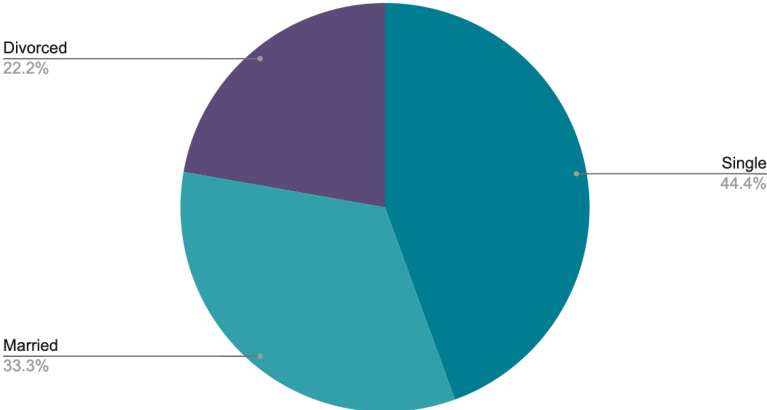


Count of Race

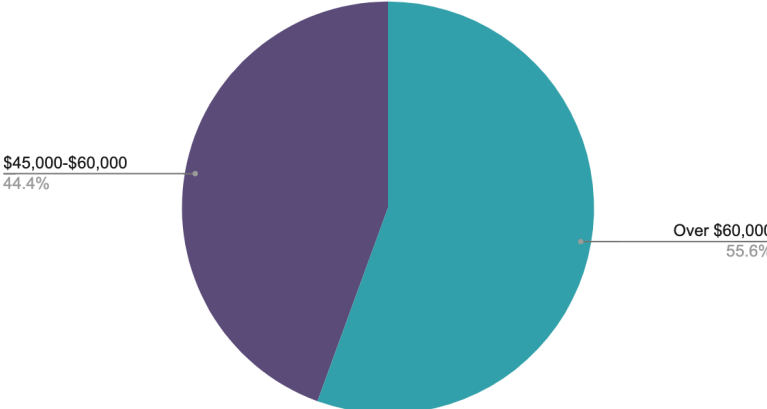

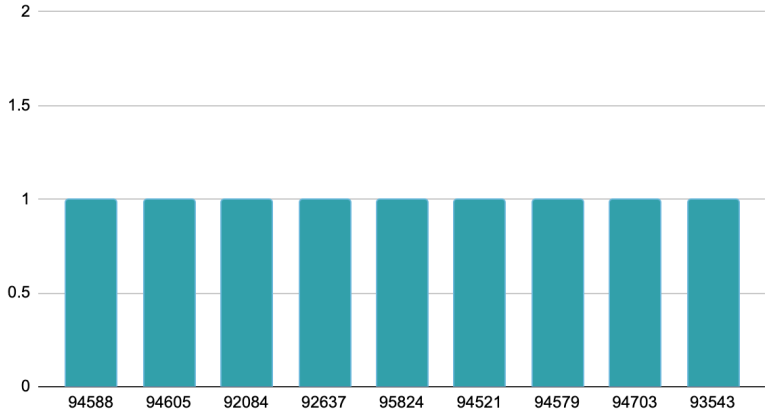
Count of Marital Status



Count of Annual Income

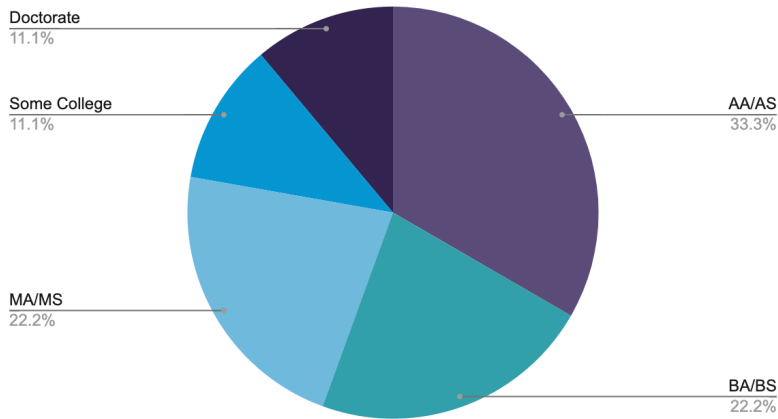

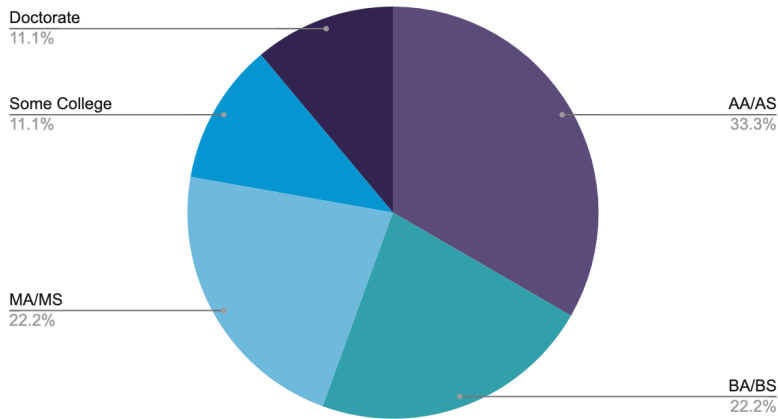

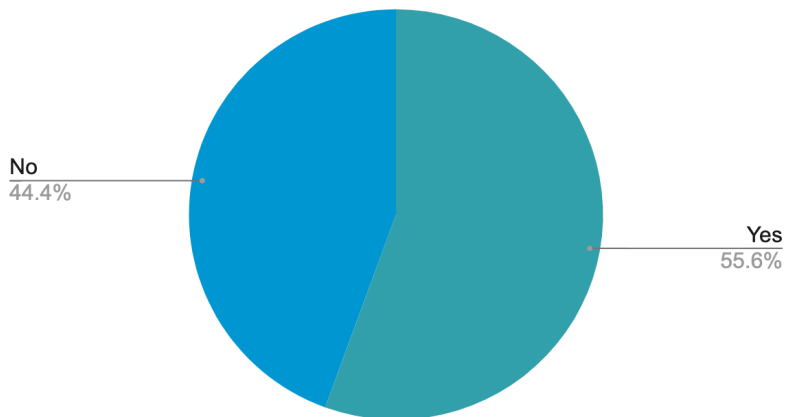
Count of Highest Education Achieved



Count of Highest Education Achieved

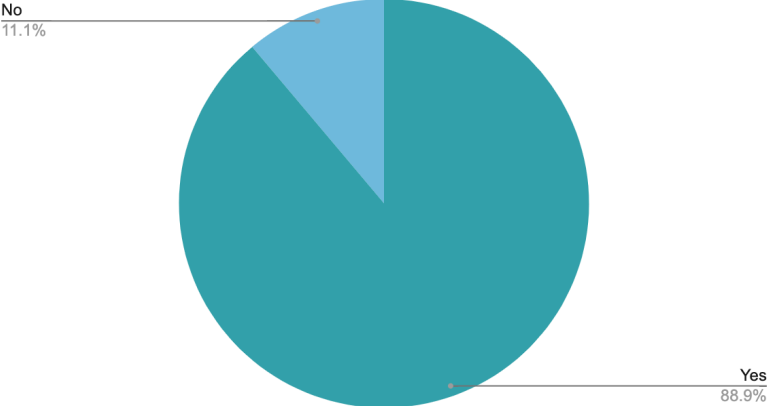


Count of childhood abuse and or neglect

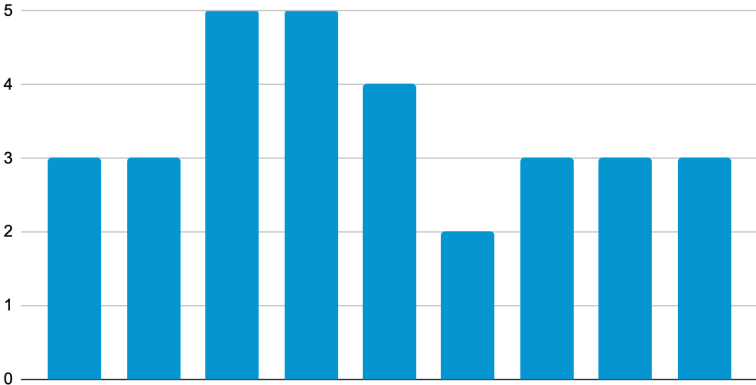

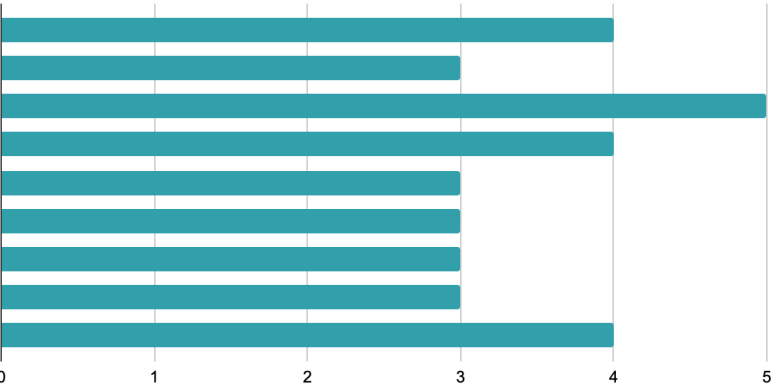
Count of Have you ever read a legislative bill?
